TERMS AND CONDITIONS

I have enclosed the payment of the registration fee and apply to enroll my child in DPS International School, Singapore.

I accept the following terms and conditions:

1. I understand that failure to disclose all necessary information on the application form, concealing pertinent information and/or altering documents, may result in any offer of a place being revoked, and, in the case of a place having been taken up, withdrawal from DPS.
2. The initial payment towards blocking of the seats for all classes @ SGD\$1000, on successful admission the same shall be accounted towards the registration fees. If the student does not join the school then the same shall be treated as a processing fees, which is non-refundable.
3. On acceptance of this application I will pay a deposit to DPS which will be refunded, without interest, when the child leaves DPS, on proper notice or payments in lieu thereof, less any amounts which are then due and payable to DPS.
4. A full term's notice, in writing, must be given to the Director of Admissions before the removal of the child and if such notice is not given, one full term's fees in lieu of such notice will be paid to DPS.
5. The Head of DPS may require, at any time, the withdrawal of the child from DPS for any cause, judged by the Head of DPS in his absolute discretion to be adequate.
6. Each quarter's fees shall be paid in advance before the commencement of DPS term to which it relates and such fees are not refundable in whole or in part.
7. I agree that my child will abide by the rules and regulations of DPS.
8. I accept that my child will be asked to take a test or to be interviewed in order to ascertain his/her English Language proficiency and or academic level. In the case of my child being a Singapore citizen, the MOE permission will be necessary.
9. I understand that cover for personal accident insurance or loss of personal possessions is my responsibility and that DPS will not provide cover for students taking part in any DPS activities (inclusive of sport).

11. Singapore citizens holding dual citizenship may not make an application based upon their non-Singaporean status.
12. Successful applicants, who hold Singapore citizenship, will only be able to take up their place at DPS after the Ministry of Education has issued a waiver.
13. Permanent Residents, who are non-Singaporean, do not require a Ministry of Education waiver.
14. Children, who become Singapore citizens, will only be able to retain their place at DPS after the Ministry of Education has issued a waiver.
15. If it subsequently becomes apparent that any of the above information has been withheld, or falsified it will lead to the immediate exclusion of the child from DPS.
16. I Understand that DPS is no way responsible for any untoward incident causing injury to the child during the school activities.

Please note that it is important to declare all significant medical, behavioural and emotional problems, which might affect your child's life at DPS. In the case of special educational needs, DPS must assess carefully whether it can provide adequate provision. If your child has previously been asked to leave another school, this information should also be provided. Failure to declare such information will result in the offer of a place being withdrawn or in your child being asked to leave DPS.
